# Expressions of interest for 2024/2025 - Diagnostic Workforce Programme

I am pleased to inform you that the portal for requesting funding for trainee places for 2024 has now opened. Requests for funding should be based on meeting the criteria for application detailed in appendix 1. A link to submit your expression of interest is provided towards the foot of this letter. Please note a submission of an expression of interest does not result in automatic allocation for funding for a post and outcomes of expressions are expected by the end of June.

These programmes are aimed at the specialist Respiratory and Sleep gaps at level 6 and level 7 to address the current workforce deficit, to backfill positions opened as existing practitioners enter advanced training in Respiratory and Sleep, and to staff the Community Diagnostic Centres (CDCs).

The Graduate Diploma in Respiratory Science includes clinical and professional modules from the PTP (together with the appropriate work-based training) and is to be completed within 12 months. Academic training is provided by either Sheffield Hallam University or the University of the West of England. The University will be allocated based on your location, and the Programme will attract a training grant of £10,200.

The Post Graduate Certificate in Sleep Medicine is a new programme designed to support the delivery of services by different staff in different settings, by educating colleagues in the underpinning science to deliver a clinical role in a chronically understaffed specialism. Academic training is provided by the University of the West of England and is completed within 12 months. The Programme will attract a training grant of £12,240.

# Appendix 1

Criteria for application:

- 1. Student Programme Requirements: To apply for the programme, trainees must have a 1st, 2:1 or 2:2 class undergraduate honours degree or an integrated master's degree, in a pure or applied science subject, or equivalent. The degree subject must be relevant to the specialism and include Human Anatomy and Physiology and research skills. By completing the following recruitment sections, the organisation is confirming their understanding of this entry requirement.
- 2. Supervision requirements: All trainees must have a clinical supervisor who will oversee the training and supervisors in each placement/rotation. <a href="https://nshcs.hee.nhs.uk/programmes/respiratory-and-sleep-training-programmes/employer-guidance-on-the-respiratory-science-and-sleep-medicine-programmes/participating-in-the-programmes/">https://nshcs.hee.nhs.uk/programmes/respiratory-and-sleep-training-programmes/employer-guidance-on-the-respiratory-science-and-sleep-medicine-programmes/participating-in-the-programmes/</a>
- **3. Workforce planning**: Please include in your application the information required for workforce planning. Either a succession plan for trainees' post qualification or how you see this post adding value to the local or national workforce for your specialty.
- **4. Programme commitment:** As an employer you are undertaking the responsibility to host the trainee for the <u>full</u> duration of their training programme. If there are service, staffing, or departmental changes, efforts should be made by the organisation to safeguard the training of trainees.
- 5. Exceptional circumstances: Should there be any exceptional circumstances during the training programme, which affect the trainee and are outside of their control, the organisation will be called upon to extend the period of training to maximise the trainee's opportunity to complete.

- b. Please note that NHSE has no control over the Department of Health funding timelines.
- 5. Application withdrawals: Please note that NHSE, together with the NSHCS can take the decision to withdraw trainee posts or trainees if the training centre is deemed as providing a poor trainee experience about work-based training and inability to deliver the training curriculum.
