



# 2025/2026 Expression of Interest

**Guidance for Organisations** 



## 1. Background

NHS England's Workforce, Training and Education Directorate is committed to supporting and expanding the national Teach and Treat programme into 2025/26, building on the success of the initial pilot in the South West (2022) and the achievements of the national rollout in 2024/25.

This expansion is part of a broader strategic investment in prescriber infrastructure within community pharmacy, delivered through:

- The national independent prescriber training offer
- The reformed foundation training programme
- The continued development of the Teach and Treat model

NHS England is investing in the future of community pharmacy by increasing the number of independent prescribers and developing the next generation of Designated Prescribing Practitioners (DPPs), strengthening clinical capacity and leadership across the sector.

### 2. What is the offer

The aim of the Teach and Treat programme is to enable community pharmacists to train as independent prescribers in supervised clinical environments, working alongside locally identified multiprofessional DPPs. This approach ensures high-quality, hands-on learning that is embedded within real-world practice and aligned with local service needs.

Individual organisations or collaborations of organisations across each NHS England region are invited to submit expressions of interest for funding of up to £100,000. Proposals should be based on an amount which demonstrates clear delivery plans aligned to the objectives of the programme.

Please note that collaborative bids must identify a lead organisation, which will be responsible for receiving payments and maintaining project governance.



Following assessment, there may be scope to offer additional funding up to 20% to successful applicants to further strengthen delivery and the evidence base. This will be considered on a case-by-case basis and is not guaranteed.

This funding is intended to:

- Facilitate access to supervision
- Enable completion of Independent Prescribing (IP) training
- Support progression into active prescribing roles

While funding may contribute to supervision-related costs, the aim is to support the development of sustainable supervision models rather than solely covering Designated Prescribing Practitioner (DPP) support. Applicants should consider how their proposals will build long-term capacity and infrastructure for supervision.

## 3. Requirements and Eligibility for Organisations

Minimum Requirements

To be eligible, the lead bidding organisation must:

- Hold or have access to a clinical environment where NHS prescribing activity takes place with a suitable scope of practice for identified community pharmacist prescribers.
- Have access to, or be able to source, Designated Prescribing Practitioners
   (DPPs) to support pharmacists through an IP course.
- Commit to enrolling eligible community pharmacists onto an IP course by 31 March 2026.
- Identify a Senior Responsible Officer (SRO) and appoint a Project Lead.

#### Note:

If your organisation does not currently meet the minimum requirements but is interested in developing prescriber and supervision capacity, we encourage you to explore our website for current offers and resources that can support your preparation for future opportunities.



## 4. Requirements for Project Management

#### **Project Leadership Requirements**

Each project must identify:

- A Senior Responsible Officer (SRO) accountable for overall governance
- A Project Lead responsible for day-to-day delivery and coordination

These roles may be held by the same individual or delegated appropriately.

#### Minimum Requirements for the Project Lead

The Teach and Treat Project Lead must:

- Be employed by an organisation that provides NHS services to patients
- Be registered with the General Pharmaceutical Council (GPhC) or another recognised healthcare regulatory body
- Be a qualified non-medical prescriber (e.g. pharmacist IP, GP, or secondary care consultant), or have in-depth knowledge of the IP accreditation process
- Be an active prescriber or understand how the qualification supports patient care
- Ensure access to a suitable prescribing environment with supervision from a Designated Prescribing Practitioner (DPP)
- Have the confidence and ability to engage local community pharmacists who meet IP course eligibility
- Hold a supervision qualification or have equivalent training/experience
- Demonstrate a strong interest in education and training, with a clear commitment to developing the future pharmacy workforce



## 5. Application Process Overview

#### **Important**

Your application will not be considered if you answer "No" to any of the minimum requirements for either:

- a. the hosting organisation, or
- b. project management,

#### Submission Method

- Applications must be submitted using the official Expression of Interest (EoI) form.
- Each application will be assessed against a defined set of evaluation criteria to determine eligibility and funding allocation.

#### **Evaluation Period**

- During the review process, panel members may contact the designated lead applicant for clarification.
- Prompt responses to any queries are essential to avoid delays.

#### Timeline Guidance

- Ensure you review the application deadline and leave time for any clarifications requested during the evaluation period.
- If contacted by a panel member, respond promptly and with the requested information to avoid delays.

- Plan for leadership development and long-term sustainability

- Outline of local infrastructure to support project delivery
- Identification of a suitable clinical setting with a prescribing mandate
- Confirmation of prescribing environment for pharmacist training
- Named project lead with organisational sign-off

#### Collaboration & Inclusion

- Engagement with community pharmacists eligible for IP training
- Option for individual or collaborative bids across organisations
- Commitment to Equality Diversity and Inclusion (EDI) with actionable steps
- Plans to address health inequalities, aligned with local population needs

#### **Evaluation & Impact**

- Framework for evaluation and benefit measurement
- Evidence of long-term impact and workforce transformation
- Readiness to respond to clarification requests during evaluation

#### Administrative Readiness

- Completed expression of interest form submission
- Reviewed application deadline and timeline guidance
- Contact details for lead applicant available and responsive

## Appendix 2

## Supervision Requirements

All pharmacists undertaking an independent prescribing course must have a Designated Prescribing Practitioner (DPP).

#### **Designated prescribing practitioner**

A Designated Prescribing Practitioner (DPP) is a healthcare professional in Great Britain or Northern Ireland with legal independent prescribing rights who supervises a health care professional during their independent prescribing (IP) course and provides 'sign-off' on their competency to prescribe.

You do not have to be a pharmacist to supervise an IP learner. The role of DPP can be performed by any independent prescriber including doctors (Designated Medical Practitioners or DMPs), nurses and Allied Health Professionals (AHPs).

The DPP must be suitably experienced and qualified to carry out this supervisory role and have demonstrated Continuous Professional Development (CPD) or revalidation relevant to their role. The personal characteristics, professional skills, knowledge, and training required to be a DPP are described in the RPS Competency Framework for Designated Prescribing Practitioners. DPPs can supervise more than one individual trainee, please refer to local HEIs for their policy on this.
